PGT® Commercial Products

Warranty

PGT Industries, Inc. ("PGT"), warrants to the original purchaser that all PGT manufactured product shall be free of material defects in manufacturing and/or materials for the period specified below after the date of delivery by PGT. This warranty applies when such products are installed in a vertical application in accordance with PGT's instructions and industry guidelines, under normal use and service, subject to the conditions and limitations herein listed. PGT'S LIABILITY UNDER THIS WARRANTY SHALL BE LIMITED TO THE REPAIR OR REPLACEMENT OF NONCONFORMING GOODS, PARTS OR GLASS, AT PGT'S OPTION. PGT SHALL NOT BE RESPONSIBLE FOR ANY INCIDENTAL OR CONSEQUENTIAL DAMAGES THAT MAY ARISE OUT OF A CLAIM FOR BREACH OF THIS WARRANTY.

This warranty covers only those manufacturing and material defects as specified herein and does not include defects or damages attributable to improper fabrication, assembly, installation, application, storage, use, or maintenance of product; normal weathering; highly corrosive or otherwise abnormal environments; defects or damages caused by accident, fire, flood, acts of God, multiple hurricanes, water intrusion, including but not limited to water intrusion caused by wind-driven rain due to high wind events, vandalism, riot or civil disorder; building settlement, excessive building movement or structural failures of walls or foundations; stresses resulting from localized heat which causes excessive temperature differentials over glass surface edges, incompatibility with other coatings, sealants, gasket lubricants, insulation, setting blocks, or any other materials; or occurrences beyond PGT's control. This warranty specifically excludes any and all applications where PGT Architectural Glass units are in excess of fifty (50) square feet or are installed in horizontal or sloped glazing projects.

PGT expressly assumes no responsibility for and this limited warranty does not cover laminated glass: (i) with edge fabrication or edges exposed to the elements; (ii) installed in structural glazing; (iii) with butt joints or point support systems; (iv) installed in or around swimming pools, spas, greenhouses or any other environment that has continuous or cyclical high moisture.

This warranty shall be null and void if full payment is not received for goods and services within the agreed upon terms of sale and credit terms; if harmful solvents are used to clean the glass or surrounding frame members; if the frame members are not maintained in accordance with AAMA standards; or if the frame members are painted or coated in any way or if any "aftermarket" products, such as window films, are applied to the PGT product. Additionally, this warranty shall be null and void if PGT Architectural Glass has not been stored, transported, installed, and maintained in accordance with PGT's Glazing Instructions as well as guidelines and procedures published by GANA, AAMA, and IGMA.

Caulking is used on some installations to seal the frames (or trim package) against water or air penetration. Caulking is not considered a part of the PGT product and, therefore, is not covered under this warranty. Caulking is normally considered a maintenance responsibility of the owner.

PGT'S SOLE RESPONSIBILITY UNDER THIS WARRANTY IS LIMITED TO REPAIRING OR REPLACING (COLOR MAY VARY DUE TO AGE, WEATHERING OR DYE LOT DIFFERENCES), FREE OF CHARGE OR AT A PRORATED PRICE PER GUIDELINES OF THIS INSTRUMENT, ANY PART OR PARTS THAT COMPLY WITH THE TERMS OF THIS WARRANTY. THE ORIGINAL WARRANTY PERIOD SHALL NOT BE EXTENDED BY SUCH REPAIR OR REPLACEMENT.

PGT reserves the right to discontinue or change the design and specification of any product it manufactures. Should the component of the window/door originally installed not be available, PGT shall have the right to substitute such part determined by PGT to be of equal quality and performance.

NO WARRANTY SHALL BE EXTENDED FOR SPONTANEOUS OR ACCIDENTAL GLASS BREAKAGE, OR GLASS BREAKAGE DUE TO ANY OTHER CAUSE.

This warranty only applies to the original purchaser and is not assignable or transferable.

IMPORTANT COVERAGE INFORMATION:

Frame

Anodize and painted aluminum components are warranted to be free of defects in materials and workmanship after the date of delivery by PGT. It is typical for anodized products to have color variation and processing marks that occur during manufacturing. These are not considered defects or covered under the warranty. Warranty is null and void if any aluminum component has direct contact with copper treated wood, such as Alkaline Copper Quaternary (ACQ).

Hardware, Screens and Moving Parts

PGT warrants that mechanical operation of hardware, screen, and moving components will be free of material defects and workmanship. The effects of naturally occurring changes such as tarnish, corrosion, oxidation, erosion, discoloration, and normal wear and tear; handles, closers, push/pull & panic bars, or other add-on hardware are specifically excluded from this warranty.

PGT Architectural Glass

All PGT Architectural Glass products must be installed within 30 days of delivery to prevent damage from moisture and potential warping. Field glazed units must conform to PGT's Glazing Instructions and GANA, AAMA and IGMA standards. Architectural Glass has prevalent characteristics such as bubbles, discolorations, blurs, and scratches. These are expected, as they are inherent qualities that meet or exceed standard specifications for flat glass ASTM C 1036, heat treated flat glass ASTM C 1048, and laminated architectural flat glass ASTM C 1172. Heat strengthened or tempered glass may have distortions as an inherent quality. Glass with special coatings may require special cleaning; follow GANA Glass Informational Bulletins 01-0300 "Proper Procedures for Cleaning Architectural Glass Products" and 02-0402 "Heat-Treated Glass Surfaces are Different" for care and maintenance.

Laminated Glass Unit

PGT Architectural Laminated Glass Units are warranted to be free of defects resulting in material obstruction of vision or delamination from the date of delivery by PGT.

Insulated Glass Unit

PGT Architectural Insulated Glass Units are warranted to be free of defects resulting in material obstruction of vision or film formation caused by dust or moisture in the dead air space of a sealed unit from the date of delivery by PGT.

Supplemental Export Warranty Language – PGT products installed outside of the continental United States limits this warranty as follows. PGT will provide replacement parts or refunds at its sole discretion, but will not be responsible for doing on-site inspections or warranty repairs.
